PESTEC INTERNATIONAL BERHAD (FORMERLY KNOWN AS PESTECH INTERNATIONAL BERHAD") ("PESTEC" or "the COMPANY") - WINDING-UP PETITION IN THE HIGH COURT OF MALAYA AT KUALA LUMPUR, PETITION NO. WA-28NCC-1326-12/2025 BY PESTECH ENGINEERING TECHNOLOGY (CHINA) CO. LTD. SERVED ON PESTECH SDN BHD, A WHOLLY-OWNED SUBSIDIARY OF THE COMPANY

The Board of Directors of the Company wishes to announce that on 22 December 2025, Pestech Sdn. Bhd. ("PSB"), a wholly-owned subsidiary of the Company, was served with a winding-up petition dated the same day ("Petition") by Messrs. Ravindran Advocates & Solicitors, acting for Pestech Engineering Technology (China) Co. Ltd. ("Petitioner"). For the avoidance of doubt, the Petitioner is not related to the Company or its subsidiaries, notwithstanding the similarity in name.

The Petition was filed in the High Court of Malaya at Kuala Lumpur for an alleged sum of USD 2,394,052.01.

The Board wishes to emphasise that the Petition and the alleged debt is disputed, and based on the current assessment, the Company does not expect any material adverse impact on the financial position or operations of the Company or the Group arising from the Petition.

The Company has sought legal advice and is taking the necessary and appropriate steps in relation to the Petition and in reference to the alleged debt not limited to opposing the Petition. The first case management has been fixed on 6 April 2026.

Any material development in respect of the above matter will be announced in due course, in accordance with the Main Market Listing Requirements of Bursa Malaysia Securities Berhad.
